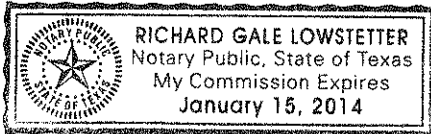
WHEREAS, such rules regarding the application of payments are necessary to the fair, efficient and cost effective management of the Association;

1. Attorney's fees;
2. Costs of collection;
3. Interest;
4. Maintenance assessments, with payments being applied to the oldest delinquent assessment first.

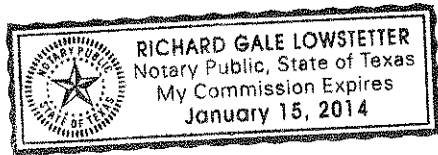

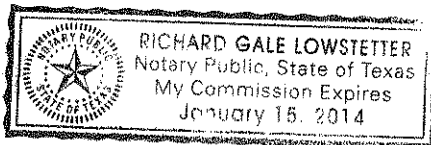
